

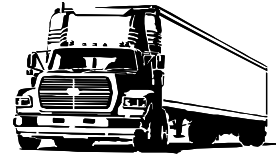

If Student already has any of these the money will not be refunded to them

Any additional test more than mentioned above will be the student's responsibility.

All students are required to pay for the State Drivers license.

Termination From Training:

A. Absences

1. Accumulated absences of more than 20 of total clock hours.
2. Participant; will be counseled by trainer of possible termination due to absences.
3. Failure to notify trainer when unable to attend.

A. Tardiness

1. Habitual Tardiness.
2. Habitual practice of leaving premises during the training day.

B. Conduct

1. Failure to participate in training activities.
2. Refusal to follow directions.
3. Failure to progress according to ability.
4. All students must represent school in a professional conduct.

C. Theft

1. Theft of ESD Truck Driving School Property.
2. Damage or destruction of property through neglect.

D. Alcoholic Beverages or Illicit Drugs

1. Zero tolerance for drugs and alcohol while enrolled in school at E.S.D. Truck Driving School, L.L.C.

E. Dismissal

Zero tolerance for drugs and alcohol while enrolled in school at E.S.D Truck Driving School. This includes lodging. Drug and alcohol use will result in immediate dismissal with no refund.

Failure to complete prescribed course in 1 ½ times length of prescribed course.

Any terminated student may apply for readmission in written request form and can only be reinstated with permission of the School Administrator. All Fees and Associated Cost will be paid upfront.

Cancellation and Refund Policy:

1. A refund will be granted to any student who cancels the enrollment contract within forty eight (48) hours (until midnight of the second day excluding Saturdays, Sundays, or legal holidays) after the enrollment contract is signed by the prospective student.
2. The student is considered as having entered training when the student has attended on regular class period of instruction at the school.
3. The school shall make refunds to the student no later than (30) days after the student withdraws or is terminated from the program. Proof of refund(s) shall be placed in the student's file. Proof shall be a photo copy of the check after it has cleared the bank. The check shall be copied front and back on the same sheet of paper, with the number of the check from the front folded so that it shows at the same time the back is
4. The effective date of the termination, for refund purposes shall be the last day of attendance.
5. In the event a student withdraws or is dismissed from the school, a refund may be due. The amount of the refund will be based on the following.

The first one hundred five dollars (\$105) paid to the school by the student will be retained as an enrollment or application fee.

All amounts in excess of one hundred five dollars (\$105) will be refunded on a pro rate basis. The pro rate basis will be based on the total program hours (160), divided by the number of hours attended, times the tuition and the cost of expenses already given hotel, physical, test fees, etc. cost of expenses shall be based upon bills incurred while the student was enrolled.

Student Grievance and Complaints:

Any and all complaints must be written and turned into the School administrator for review and consideration.
